The following information is submitted to the Town of Marlborough Planning Board for review and consideration in connection with the application of Garone's Mountain Fresh Farm and are in response to the comments received from McGahey, Hauser and Edsall dated June 26, 2019:

1. The gravel parking lot at the site is existing and was previously used seasonally in connection with the tree farm. Details of the landscape material storage bins have been added to the plan.
2. The sanitary disposal system was installed in the late 1980's when the building, then used as the farm office and hangar for the helipad, was constructed. It serves the one bathroom which consists of a sink and lavatory. A new well is proposed as the water supply is currently shared with the well shown on adjoining lands of Crimi-Varoli.
3. The site is well screened from Bailey's Gap Road and Orchard Road.
4. A package is submitted for referral to the Ulster County Planning Board.

A site plan was not previously required for this parcel as the uses were limited to agricultural growing, equipment storage and maintenance, and seasonal sales. Please refer to the determination from the Building Inspector indicating that the expansion of the agricultural to include landscaping with year round use has triggered the necessity of a site plan. The helipad was previously determined to be allowable for personal use only. The current owners do not plan to utilize it, but do want to continue to make it available for emergency services if the need ever arises.

The existing site lighting on the south end of the building will be replaced with full cut-off fixture as depicted in the attached cut sheet (or comparable), and the motion detector security light on the east side of the building will remain. The business does not operate after dark so no additional lighting is required.

Thank you for your continued assistance in the review of this project.

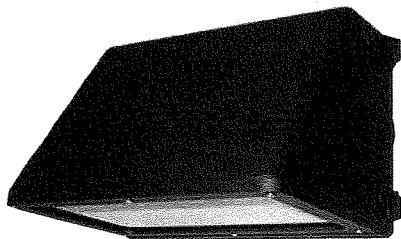

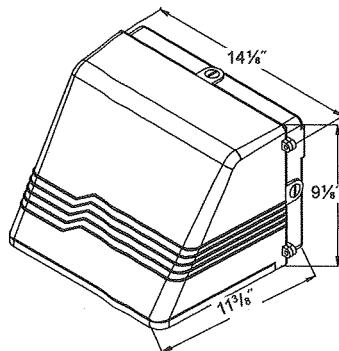
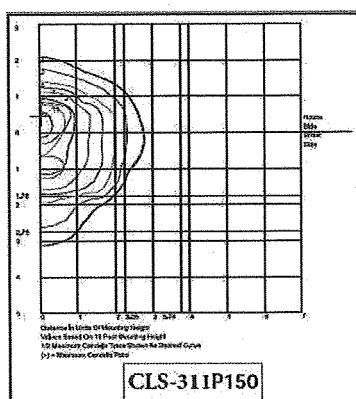
