

Re: Verizon Wireless – Special Permit and Site Plan Review

Summary

The applicant is proposing a 90' monopole wireless telecommunications facility at 50 Cross Road (Marlboro Central High School) in the R-1 zoning district.

Recommendations

Public Safety – Required Modification

Wireless facilities serve as an opportunity for local public safety entities to increase their coverage area and quality. It is recommended with this tower, as with any proposed telecommunications facility of its time, that the right to place public safety wireless facilities such as, but not limited to, the Town, local and state police, local fire district, and County, be reserved for their use should they require it.

Additional Visual Analysis - Advisory Comment

It came to staff's attention after our meeting that an additional balloon test and visual analysis will be conducted and may include additional locations to judge their visual impact. If any changes to the content of the visual analysis are made, it is recommended that this application be re-referred for review of those and any other additional materials to be considered as part of the "Full Statement" requirements under General Municipal Law.
