Consultant's Additional Services

- A. Behan Planning and Design has prepared a conceptual plan for a new crossing of the CSX rail line at Milton Landing Park. The town has received CSX responses to that conceptual plan and the Town has determined that the proposed new crossing will be in conformance with the legal decision rendered in favor of the town to replace the existing crossing.
- B. The Town has requested Behan Planning and Design to provide planning and landscape architectural design services with engineering services provided by Pitingaro and Doetsch Consulting Engineers, P.C., to further advance the planning and design of the crossing in conformance to project requirements as established by CSX and NYSDOT as accepted and agreed by the Town.

Consultant will provide services as required including but not limited to preparation of draft responses and related documents for use by the Town, preparation of design documents, and materials recommendations to advance design agreement details for the proposed new crossing with the project participants (NYSDOT, CSX/Bergman, Town of Marlborough).
