The following information is submitted to the Town of Marlborough Planning Board for review and consideration in connection with the application of Jeffrey Aldrich for a Two Lot Subdivision and are in response to the comments received from MHE Engineering dated June 02, 2023.

1. Project proposes a two-lot subdivision of a large parcel of property. Proposed Lot #1 will contain the existing Little League fields off of New Road. No other proposed improvements are identified.

Comment noted

2. Existing vehicles parked on Lot #2 near the Milton Turnpike frontage should be addressed.

This site has an existing Junk Yard License that permits the vehicle parking. A copy of the permit is included with this submission.

3. Percolation and deep testing should be performed on Lot #2 to identify a buildable area. While the lot is 12.42 acres, extensive wetlands exist on the site.

Percolation and deep test pits have been performed by Willingham Engineering and a suitable site was found for the design of fill systems for a primary and reserve septic system as per attached email and sketch.

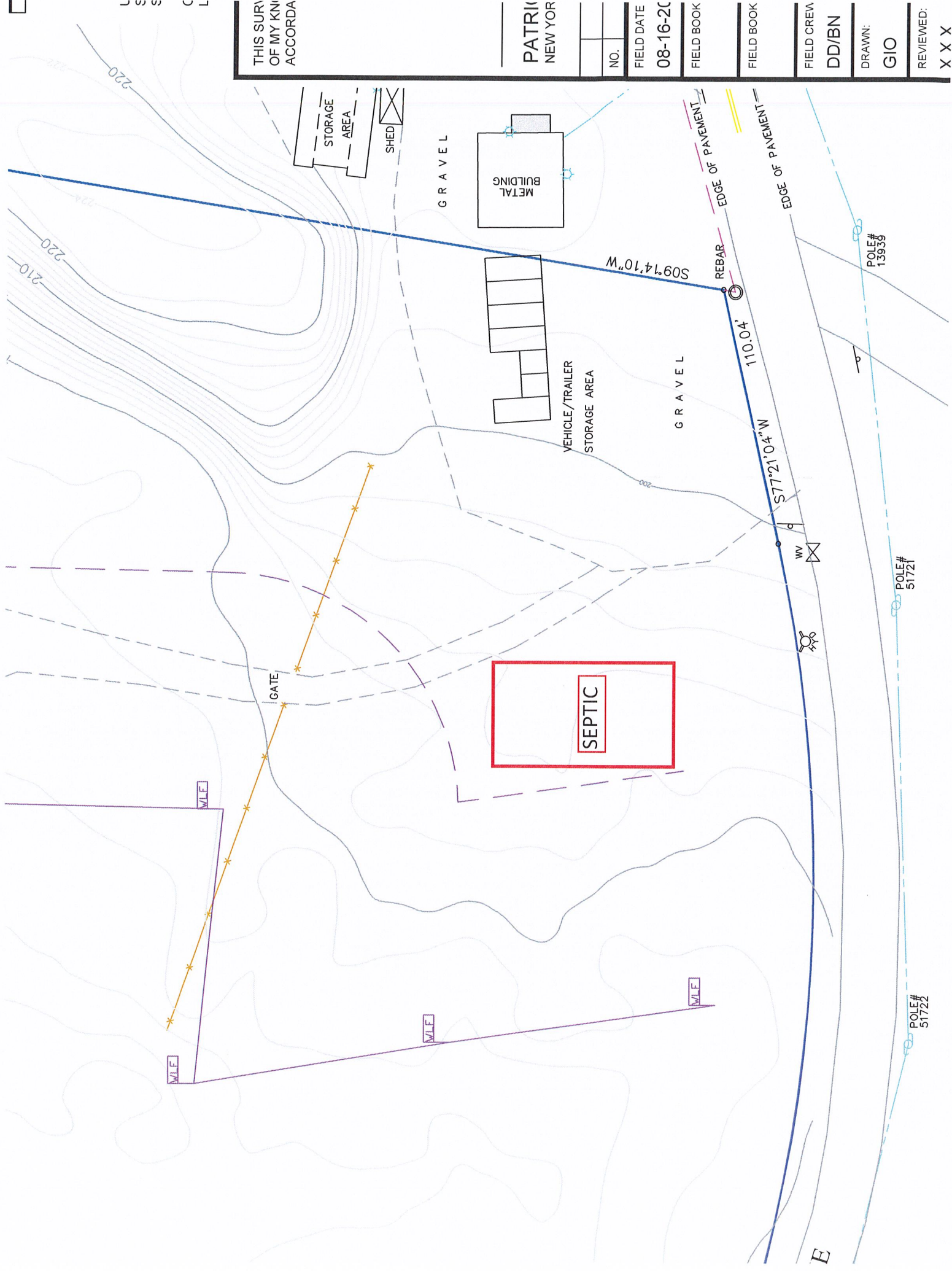
