



Environmental Findings

- The SWPPP is completed and we are able to meet all water quality and peak flow requirements. Green infrastructure practices such as porous pavement will be implemented to provide infiltration and reduce runoff.
- Our habitat assessment shows that impacts to bats can be mitigated by clearing between November and March.
- Pesticides in agricultural soils can be managed on-site with capping beneath landscaped berms and the solar area.
- No significant adverse traffic impacts to the existing roadway network.
- No viewshed impacts.
- HECRAS update is provided, requires bridge selection to complete but will mitigate flooding with increased span and additional drainage.
- Accoustical impacts can be mitigated and ownership has committed to an approach outlined in the report.

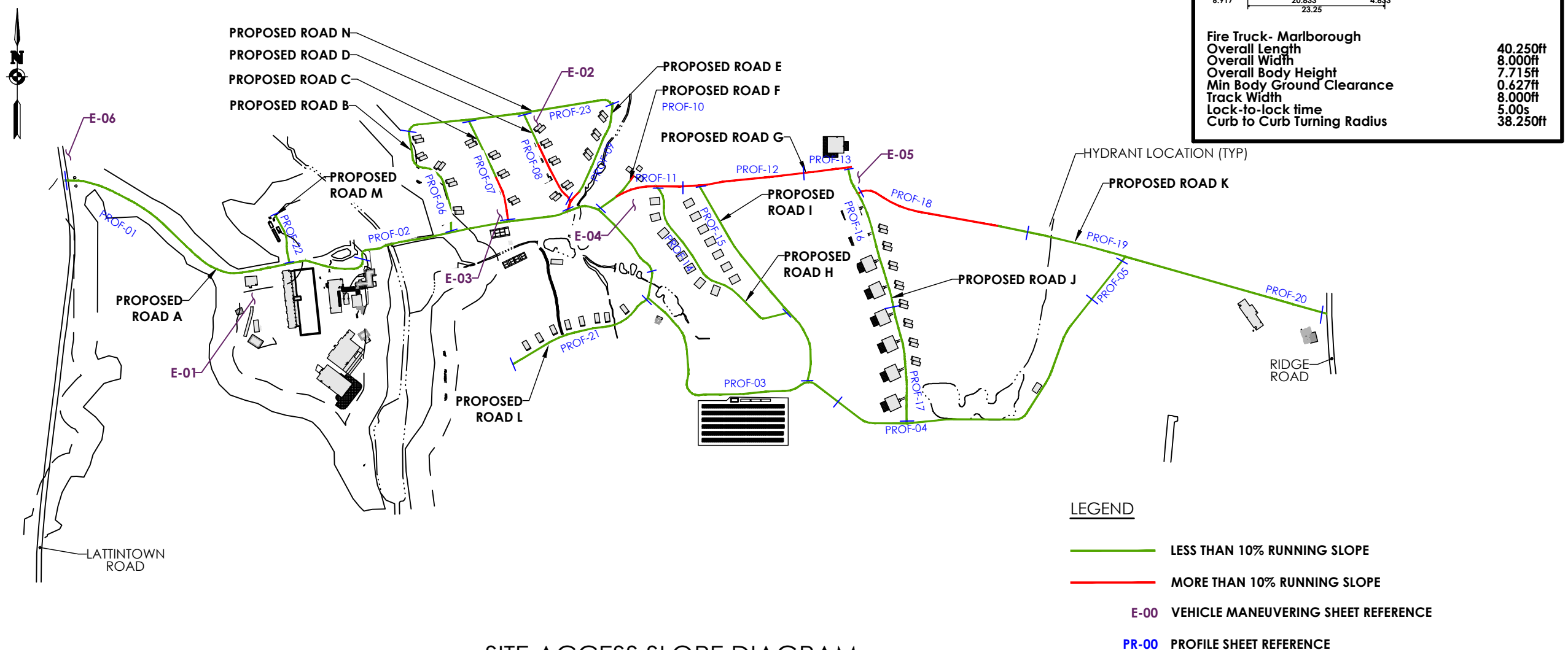
Other Submission Contents

- The Civil Plan Supplement has been created to address roadway design and emergency access.

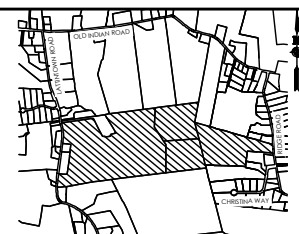
CIVIL PLAN SUPPLEMENT: FIRE ACCESS & ROADWAY DESIGN
